








Lobbying Spending Reaches New Record in 2022

Lobbying spending in Washington reached a new high of \$4 billion in 2022, continuing a multiyear streak driven by a law aimed at climate change and inflation, plus measures steering tax money into highways and semiconductor manufacturing.

That extended a trend. Advocacy spending has been steadily climbing since the election year of 2016, when years of decline sent spending to a low point of \$3.13 billion.

Bloomberg Government analyzed Lobbying Disclosure Act reports from all 2,105 registered lobbying firms that filed with the Senate during 2022. This report focuses on 363 firms that reported \$1 million or more in revenue and lobbying activity in each quarter of the year.

Year-Over-Year Growth

Lobbying firms of all sizes reported revenue gains in 2022, with No. 1 Brownstein Hyatt Farber Schreck growing its business by more than \$4 million.

The biggest lobbying shops continued to be Brownstein, Akin Gump Strauss Hauer & Feld, and Holland & Knight.

Rounding out the top 10: BGR Government Affairs, Invariant, Cornerstone Government Affairs, Thorn Run Partners, Capitol Counsel, Squire Patton Boggs US, and Forbes Tate.







Lobbying firms with the most revenue, 2018 through 2022 (in USD millions)








Standout Firms of 2022

The BGOV analysis found that 82 of the 363 firms with \$1 million or more in revenue also achieved high scores on other metrics.

These standout firms retained 80% or more of their clients from 2021 and 60% or more of their clients over three years. They also posted figures showing revenue-per-lobbyist of \$550,000 or more.

BGR Government Affairs hit all of those metrics and was one of the top-grossing lobbying shops of the year. Todd Strategy LLC made the list of standout firms for the sixth consecutive year. Bracewell LLP also is on the list for a sixth time.

On the list for the first time: 23 firms. The lobbying shops that met the standards for the "standout" designation are identified in the chart on the following 11 pages.

2022 Lobbying Report: Behind the Data

Analyst: Jorge Uquillas

Bloomberg Government analyzed Lobbying Disclosure Act reports from all 2,105 registered lobbying firms that filed with the Senate during 2022.

This annual report focuses on firms that reported \$1 million or more in revenue and lobbying activity in each quarter of the year. To identify top-performing firms, the data was filtered by five business performance metrics: growth in revenue, growth in average revenue per client,

short- and long-term customer retention rates, and revenue per registered lobbyist.

The analysis takes into account that the law allows firms to report no precise amount when a client's quarterly activity is less than \$5,000. For amounts larger than that, firms disclose spending to the nearest \$10,000.
