## Lobbying spending again topped \$4 billion

#### **Year-Over-Year Growth**

The lobbying firms reporting the most revenue remained unchanged in 2023: Brownstein Hyatt Farber Schreck, with \$62.7 million, followed by Akin Gump Strauss Hauer & Feld, Holland & Knight, and BGR Government Affairs. Rounding out the Top 10: Cornerstone Government Affairs, Invariant, Thorn Run Partners, Capitol Counsel, Forbes Tate Partners, and Crossroads Strategies.

Federal lobbying spending topped \$4 billion in 2023 for the second consecutive year. Gains almost kept pace with inflation - a 3.1% year-over-year increase - despite the upheaval in Congress that thwarted action on many bills and culminated in two abrupt replacements of the speaker of the House.

Bloomberg Government analyzed Lobbying Disclosure Act reports from every firm that was registered with the Senate and House in 2023. This report focuses on the 381 firms that reported \$1 million or more in revenue for the year.





# Lobbying Spending Hits New Record With Tax, Al Issues Looming

Despite few new bills becoming law in the chaotic Congress of 2023, the full-time influence industry had another record year as lawmakers started laying the groundwork for future measures on taxation and artificial intelligence.

Disclosures required by law showed \$4.27 billion in spending last year, up from \$4.14 billion, according to a Bloomberg Government analysis.

That 3.1% increase – just short of the 3.4% increase in the Consumer Price Index – was posted as the pace of routine legislative activity slowed and both lawmakers and advocates started looking ahead to the next big things, such as the looming expiration of major provisions of the 2017 Tax Cuts and Jobs Act.

Unless Congress acts, individual income tax rates will revert to their 2017 levels; the standard deduction will be cut roughly in half; the personal exemption will return while the child tax credit will be cut; and the special 20% tax deduction for many pass-through businesses will disappear, according to the nonpartisan Tax Policy Center.

That will put tremendous pressure on Congress to do a major tax bill in 2025, no matter who is in control of the White House, House, and Senate.

"One of my colleagues described it as taxmageddon," said Erik Olson, president of Venn Strategies. "We will see if that's really the right way to describe it, but we're certainly heading down that path."

Todd Wooten, a partner at Holland & Knight, described the 2025 sunsets in sports terms, saying the Super Bowl of tax legislation spurred corporations with a stake in the outcome into starting early to build relationships with leaders of the tax-writing House Ways and Means Committee and Senate Finance Committee. "The smart people are the ones who are engaging now," Wooten said.

Karishma Shah Page, a partner at K&L Gates and member of the firm's public policy and law practice, said the farm bill also helped drive lobbying spending in 2023. Congress opted for a one-year extension rather than a full reauthorization of the multi-faceted policy measure that covers agriculture policy and food assistance programs.

"In many ways, what we're seeing is that stakeholders really feel as though they need to be proactive and prepared on an ongoing basis," Page said. "If and when the train is coming, they're there on the platform with the ticket with a bag packed and ready to go, even if there's no schedule for when the train's going to arrive or depart."

"It's just simply too late by the time they're ready to pass something. At that point it's been litigated so many times, you've missed the opportunity to be part of it."

And shaping legislation can be only a first step for companies affected by federal decision-making. Executive branch agencies in charge of implementing new laws seek input as they write regulations that determine how those laws will work in practice.

Lobbyists interviewed said their clients had a lot of interest in the decisions health and energy agencies made in carrying out sweeping mandates of the Inflation Reduction Act (Public Law 117-169).

For example, the law gave the Medicare program new power to negotiate some drug prices, leaving it to federal officials to work out many of the details for that process. Pharmaceutical companies including Pfizer, Merck, Novartis, and Genentech hired lobbyists in 2023 to help them make their arguments to federal officials during this process.

Tech firms including Texas Instruments and TSMC, Nvidia, and Samsung hired lobbyists to represent them in discussions about carrying out the mandates of a law intended to beef up the domestic semiconductor industry, the CHIPS and Science Act (Public Law 117-167).

"You go down the list and there was a lot going on there," Steve Elmendorf, a longtime lobbyist and a co-founder and managing partner at Avoq, said of 2022 legislation that was in the regulatory pipeline during 2023.

Some of the tech firms also hired lobbyists last year to represent them as Congress started considering options for legislation on artificial intelligence (AI), a process that has continued in 2024 with hearings by the House Energy and Commerce Committee and the Senate Finance and Judiciary committees.

"It is difficult sometimes to figure out where all this is going," Wooten said. "But it is happening. Things are absolutely taking shape."





## Firm Mergers Trigger Name Changes, New Business

Familiar lobbying shops have been reintroducing themselves to colleagues and clients under new identities.

Some firms adopted new names after mergers while others rebranded to showcase expanded aspirations.

Wynne Health Group's original identity was centered on its founder, Billy Wynne, a former Senate Finance Committee health policy counsel. In June 2023, the firm changed its name to Impact Health Policy Partners as it brought on board a new chief executive, Yvette Fontenot, with Wynne continuing as chairman.

"The new name conveys exactly what we wanted to new potential clients and has a unifying effect for us," said Fontenot, a veteran of the Senate Finance Committee, House Energy and Commerce Committee, and the Obama White House. "It's definitely helped with the transition."

Rachel Pearson in 2023 rechristened Pearson & Associates as The Complete Agency, and Hobart Hallaway & Quayle became Venture Government Strategies.

Venture's original marquee members, all of whom remain, include Robert Hobart, who had been a key staffer for members of the House Appropriations Committee; Rashid Hallaway, a former adviser to then-Sen Evan Bayh (D-Ind.); and Ben Quayle, who served one term in the House as a Republican representing an Arizona district and who is the son of former Vice President Dan Quayle.

Its current partner lineup additionally includes former four-term Rep. Kevin Yoder (R-Kan.), who served as a senior member of House Appropriations, leading at times its Homeland Security and Legislative Branch subcommittees.

The former Elmendorf Ryan, led by expatriates from the offices of ex-Rep. Dick Gephart and ex-Sen. Harry Reid, was renamed Subject Matter after a 2015 merger, and in 2023 it went through a corporate marriage with Kivvit.

Earlier this year it announced that both legacy names have been retired. The firm is now called Avōq, a name that helps it promote services in new ways, said Steve Elmendorf, managing partner and co-founder.

Cypress Advocacy's name was changed after internal conversations about the future direction of its business. By 2020, it was growing beyond its roots as an adviser to the financial services industry, explained Langston Emerson, a partner at the firm that's been rebranded as Mindset Advocacy.

The updated name helps draw attention to the firm's expanding breadth, with more work being done on energy, environmental, health care, retirement, tax, and telecommunications, said Emerson, who was involved in the process, which he said required some deep reflection among the firm's leadership. "It was a process of us describing to them who we were and where we wanted to go," Emerson recalled.









# Firms With Largest Percentage Increases in Revenue

## **Standout Firms**

BGOV's analysis found that 68 of the 381 firms with \$1 million or more in revenue also achieved high scores on other metrics.

Those firms retained 80% or more of their clients from the preceding year and 60% or more of their clients over the past three consecutive calendar years. They also posted figures showing revenue-per-lobbyist of \$550,000 or more.

All of the firms that met the standards for the "standout" designation are identified in the chart on the following 11 pages.

# Lobbying Report: Behind the Data

Bloomberg Government analyzed Lobbying Disclosure Act reports from every firm that filed with the House and the Senate during 2023. This annual report focuses on the firms that reported at least \$1 million in revenue as well as lobbying activity in each quarter of the year.

To identify top-performing firms, the data was filtered by five business performance metrics: growth in revenue, growth in average revenue per client, short- and longterm customer retention rates, and revenue per registered lobbyist.

The analysis takes into account that the law allows firms to report no precise amount when a client's quarterly activity is less than \$5,000. For amounts larger than that, firms disclose spending to the nearest \$10,000.

Note: Some filings for 2022 were updated following publication of BGOV's 2022 report.
