The Bloomberg Euro Aggregate: Corporates - Intermediate Index measures the investment grade, fixed-rate, Euro-denominated securities issued by corporate issuers. The index includes publicly issued securities by industrial, utility, and financial issuers with at least EUR 300mn amount outstanding. The index was created in December 2004, with history backfilled to January 1, 1999. The features specific to this Index are set out below.
