

Bloomberg Municipal 5-20 Years (4-20) Index

The Bloomberg Municipal 5-20 Years (4-20) Index is a measure of the US municipal tax-exempt investment grade bond market. It includes general obligation and revenue bonds, which both can be pre-refunded years later and get reclassified as such. The effective maturity of the bonds in the index must be greater than or equal to 4 years but less than 22 years. The index was created in December 2015, with history back to January 1, 2004.

Features Specific to this Index

Maturity Eligible bonds should have an effective maturity greater than or equal to 4 years but less than 22 years, regardless of optionality.
