The determination as to whether an index is a Qualified Index is made on the first business day of the applicable calendar year.¹

Does not contain any single U.S. security that represents more than 15% of the index weighting	
Does not contain any collection of five or fewer U.S. securities that together represent more than 40% of the index weighting	
Modified or rebalanced only according to publicly stated, predefined criteria, which may require interpretation by the index provider or a board or committee responsible for maintaining the index	
Did not provide a dividend yield in the immediately preceding calendar year that exceeded 150% of the annual dividend yield reported on the S&P 500 index for that year	
Referenced by futures or option contracts that trade on a national securities exchange, a domestic board of trade designated as a contract market or certain foreign exchanges described in the Section 871(m) regulations	
Passive index based on a diverse basket of publicly traded securities that is widely used by numerous market participants
