NOTICE OF AMENDMENT – MIFID II / MIFIR MARKET DATA OBLIGATIONS BLOOMBERG DATA REPORTING SERVICES DATA SERVICES

This Notice of Amendment (this "<u>Notice</u>") amends SR's Data Subscription Agreement (the "<u>Agreement</u>") with **BLOOMBERG DATA REPORTING SERVICES LIMITED** ("<u>BDRSL</u>") and **BLOOMBERG DATA REPORTING SERVICES B.V.** ("<u>BDRS BV</u>", and, together with BDRSL, "<u>BDRS</u>"), with effect from **January 1, 2022**. The term "SR" and all other capitalized terms not otherwise defined herein shall have the definition set forth in the Agreement.

BDRS is subject to certain obligations (the "<u>Market Data Obligations</u>") under Directive 2014/65/EU ("<u>MiFID II</u>"), Regulation (EU) No 600/2014 ("<u>MiFIR</u>") and related implementing legislation, delegated acts, technical standards and guidance. References to MiFID II, MiFIR and other EU regulations include equivalent United Kingdom requirements.

In order to comply with the Market Data Obligations, BDRS is required to clarify the following points related to the Agreement:

First, if BDRS audits SR for potential non-compliance related to fees and charges, BDRS is not seeking to generate additional revenues beyond what BDRS would have received had SR complied with the terms of the Agreement. Recovery of revenues may include the retroactive application of fees and charges that otherwise would have been payable.

Secondly, if BDRS audits SR for potential non-compliance with the Agreement, BDRS expects SR to provide the following minimum records for the preceding three (3) year period:

- (1) information on individual end-users with respect to entitled/enabled Data, including the periods of entitlement/enablement for each relevant category of Data; and
- (2) general descriptions of SR's policies and procedures to comply with the terms of the Agreement.

BDRS will limit any such audit to what is necessary to detect non-compliance with the terms of the Agreement.

This Notice amends and supplements and forms part of the Agreement. Except as set forth in this Notice, the Agreement shall remain unchanged and in full force and effect.
