#### Description

Bloomberg Europe & US Top Pharmaceuticals 2022 Decrement 5% Return Index is an equal weighted equity benchmark consisting in a fixed basket of five European and five US pharmaceuticals companies. This flat-rate levy, set when the index was designed, has a negative impact on its level compared to the same index with gross dividends reinvested, without a flat-rate levy. If the gross dividends distributed are lower (respectively higher) than the standard levy level, the performance of the index will be penalized (respectively improved) compared to a classic non-reinvested dividend index.
