Description

Bloomberg Inflation European Equity Winners 2022 Decrement 50 point Return Index is an equal weighted equity index consisting in a fixed basket of ten European companies. These companies have been historically well positioned to benefit from rising inflation thanks to their pricing power and revenues derived from long term inflation-linked contract. This flat-rate levy, set when the index was designed, has a negative impact on its level compared to the same index with gross dividends reinvested, without a flat-rate levy. If the gross dividends distributed are lower (respectively higher) than the standard levy level, the performance of the index will be penalized (respectively improved) compared to a classic non-reinvested dividend index.


