
# **Bloomberg Multi-Tenor Indices**

The Bloomberg Multi-Tenor Indices aim to track the performance of an equal-weight basket with 3 tenors of commodity futures contracts (Brent Crude Oil, Natural Gas, and WTI Crude Oil) beyond the nearby contract, as depicted in Table 3. The Total Return versions are calculated using the returns of the underlying excess return index and the return of cash collateral invested in the 3-Month T-Bill.
