## **Bloomberg Transatlantic Top Banks Decrement 50 point Index EUR**


#### **Description**

Bloomberg Transatlantic Top Banks Decrement 50 point Index is composed of the largest ten companies classified into Banking from the Eurozone and the US. The Index weights are tilted so that the weight of each region represents 50% of the Index. This flat-rate levy, set when the index was designed, has a negative impact on its level compared to the same index with gross dividends reinvested, without a flat-rate levy. If the gross dividends distributed are lower (respectively higher) than the standard levy level, the performance of the index will be penalized (respectively improved) compared to a classic non-reinvested dividend index.


