Description

Bloomberg US Top Banks Decrement 50 point Index is a market capitaliation weighted benchmark composed of the largest ten companies classified into Banking from the US. This flat-rate levy, set when the index was designed, has a negative impact on its level compared to the same index with gross dividends reinvested, without a flat-rate levy. If the gross dividends distributed are lower (respectively higher) than the standard levy level, the performance of the index will be penalized (respectively improved) compared to a classic non-reinvested dividend index.


