# **Australian Aggregate 100mn Index**

The Bloomberg Australian Aggregate 100mn Index measures the investment grade, AUD-denominated, fixed-rate bonds with at least AUD100mn par amount outstanding. The index tracks bonds to their final maturity and includes treasuries, government-related, corporate and securitized issues. Australian Aggregate 100mn-eligible securities with at least one year remaining to maturity and at least AUD300mn par amount outstanding also contribute to the multi-currency Asian-Pacific and Global Aggregate Indices. The Australian Aggregate 100mn Index was created in June 2014 with history backfilled to July 1, 2010.
