HKD HIBOR Fallback Restatement

Following a review and analysis between Bloomberg and the Treasury Markets Association, Hong Kong, 18 historical HONIA data points have been identified as being incorrect on dates ranging between 28 January 2010 and 3 September 2015.

While most of the impact on published values are in the back-test period, Fallback Rates for the 12M tenor for HKD HIBOR were impacted for five days post-launch of the IBOR Fallback calculations.

Files have been republished and values on the Terminal have been updated. Please see Figure 1 below for a list of impacted Fallback values.
