Ticker

Securities with Switzerland as their country of risk are excluded from the index. Eligible treasuries are denominated in the native currency of their country of risk.

Fiscal Strength Weighting

This index applies a Fiscal Strength Weighting structure that weights securities in the index based on the Fiscal Strength Weighted Country Score of their country of risk. This score is calculated as a weighted average of that country's Debt/GDP Score, Deficit/GDP Score, and Current Account Balance/GDP Score, whereby:

Fiscal Strength Weighted Country Score =

(50% * Debt/GDP score) + (25% * Deficit/GDP score) + (25% * Current Account Balance/GDP score)

The Fiscal Strength Weighted Country Score of a given security then acts as a multiplier applied to the Market Value of the security to arrive at the Market Value of the security in the index.
