

Bloomberg Germany Treasury Bond Index

The rules of this Index are described in the [Bloomberg Euro Aggregate Index Methodology](#) with the additional country constraint described below. These documents collectively constitute the index methodology for this Index.

The Bloomberg Germany Treasury Bond Index is a subset of the Euro Aggregate Index, consisting of only treasuries with Germany as the country of risk. This index differs from the treasury portion of the Euro Aggregate index by being downgrade tolerant: should Germany's credit rating get downgraded to high yield, this index would continue to represent German treasury debt. This index was launched in May 2012, with history backfilled to its inception of June 1998.
