It tracks fixed and floating-rate US dollar-denominated debt issued by EM issuers with government affiliations. Local law bonds are excluded. The index was launched in April 2013, with history backfilled to January 2013.

Features Specific to this Index

Sector USD-denominated debt from agencies (government owned, government guaranteed, and government

sponsored entities), local authorities, and sovereigns is eligible.

Country Debt whose country of risk includes Czech Republic, Israel, South Korea, and Taiwan is excluded.

Minimum Liquidity Requirements

- USD 500mn minimum par amount outstaning for debt classified as sovereign.
- USD 1.5bn minimum par amount outstanding, except for debt classified as sovereign.

Issuer Capping Methodology

Designed to comply with RIC diversification requirements where no single issuer exceeds 25% of the total index in market value and the summed weight of all issuers above 5% does not exceed 50% of the total index. This index applies a variation of the diversification requirements in that no single issuer exceeds 20% of the total index and the summed weight of all issuers above 5% does not exceed 48% of the total. Government guaranteed issuers and sovereigns that have the same country of risk are grouped together and treated as the same issuer.

Security Type

- Locally issued bonds are ineligible.
- Eurodollar with 41 or more days of seasoning are eligible.

Placement Type

SEC registered, 144A/Reg S, and seasoned Eurodollar bonds are eligible

Publication Currency
