**Fiscal Strength Weighting** 

This index applies a Fiscal Strength Weighting methodology that is a rules-based alternative weighting methodology that uses fundamental country scores to adjust natural market value weights in existing treasury/government bond indices. The Fiscal Strength Weighted Country Score is calculated as a weighted average of that country's Debt/GDP score, Deficit/GDP score, and Current Account Balance/GDP score, whereby:

Fiscal Strength Weighted Country Score =

(50% \* Debt/GDP score) + (25% \* Deficit/GDP score) + (25% \* Current Account Balance/GDP score)

Country scores (between 0 and 10) are used as a country-specific multiplier applied to the market value of each index-eligible country. These adjusted market values are then normalized to calculate Fiscal Strength Country Index Weights.
