CAD-denominated bonds with market of issue "Euro MTN" or "Euro Non-Dollar" are excluded. This index was launched in January 2001, with history backfilled to September 2000.

Credit Rating Securities must be rated AAA using the Bloomberg index rating methodology. When a rating from only two agencies is available, the lower is used; when only one agency rates a bond, that rating is used. In cases where explicit bond level ratings may not be available, other sources may be used to classify securities by credit quality.

Market of Issue CAD-denominated bonds with market of issue "Euro MTN" or "Euro Non-Dollar" are excluded.
