

# Bloomberg U.S. Strips 25+ Year Select Index

The rules of this Index are described in [Bloomberg US STRIPS Index](#) ("Parent Index") with the exception of the "Features Specific to this Index" described below. These documents collectively constitute the index methodology for this Index.

The Bloomberg U.S. Strips 25+ Year Select Index measures US dollar-denominated, fixed-rate, Separate Trading of Registered Interest and Principal of Securities (STRIPS) registered with the US Treasury's Bureau of Public Debt. The index includes interest and principal payments stripped from existing US Treasury notes and bonds. STRIPS are excluded from the US Treasury index because their inclusion would result in double-counting. Securities must have at least 25 years until final maturity, regardless of optionality. And only top 30 bonds with largest amount outstanding are selected. The index was launched in July 2024, with history backfilled to January 1, 2019.

<b>Maturity</b>	At least 25 years until final maturity, regardless of optionality
<b>Amount outstanding</b>	Top 30 bonds (Cusip) with largest amount outstanding are selected.
