Quick Facts

Weighting	Commodity weightings are based on production and liquidity, subject to weighting restrictions applied annually such that no related group of commodities constitutes more than 33% of the index and no single commodity constitutes more than 15%. Between rebalancings, weightings may fluctuate to levels outside these limits.
Review Frequency	Rewighted and rebalanced annually on a price-percentage basis.
Roll Schedule	To avoid the physical delivery of commodities from the underlying futures, the indices' roll from current to subsequent contracts during the roll period defined in the methodology, which typically falls within the 6th-10th business day of each month.

Calculation Frequency	Every 15 seconds
