The Index applies these rules on top of the Bloomberg Stable Income Market Index, a composite index in which the Bloomberg 1-5 Yr Gov/Credit Index is fixed at 65% index weight at each month-end rebalance. This means that constituents in the Index inherit the same scaling schedule as applied in the Bloomberg Stable Income Market Index. The index was created in May 2011, with history backfilled to July 1, 1999.
